



BIESSE: the American Subsidiary shines at the Fair of Las Vegas - Nevada

Orders for over 6.5 million dollars collected at the AWFS in Las Vegas - Nevada

Pesaro, 25 July 2007 - Biesse S.p.A., company quoted in the STAR segment of the Italian Stock Exchange, on the occasion of the AWFS – Association of Woodworking & Furnishings Suppliers - (Las Vegas - Nevada USA - 18/21 July 2007) has obtained orders for woodworking machines for over **6.5 million dollars (+36.9%** compared with the fair of 2005). The biennial event - together with the IWF of Atlanta - is one of the most prominent and eagerly awaited of the North American market. It has produced an **excellent result for the Wood Division of Biesse S.p.A.**, particularly important as it comes despite the continuing weakness of the U.S. Currency in relation to the Euro, and the recent conflicting indications about the state of health of the economy.

The Subsidiary of the Pesaro group – Biesse America Inc.- has thus confirmed its ability to recover a considerable market share, in a geographical area that has always been considered strategic for the development and growth of Biesse.

“We're very pleased about the result obtained in Las Vegas (AWFS)” said the president of Biesse S.p.A., Roberto Selci, “because it comes at a time that is anything but expansive for the North American market - a market that is vitally important for us. It's another positive piece of news, to add to the very good results achieved so far and the equally good ones that we're about to approve (Biesse Board of Directors 8 August next month - Consolidated 2nd quarter 2007 results).”
